# Mail-in Ballots

Carefully Follow Procedures for Mail-In Balloting to Ensure Your Vote Counts:

- **1.** Request a ballot by completing a request form by:
  - a. Calling 1-800-286-5636 to request form
  - b. Picking up the form at our office at 91 West US Highway 160, Lamar, Missouri
- 2. Complete the ballot by selecting up to a total of three (3) candidates. If more than three (3) candidates are selected the ballot will not be valid.
- **3.** Put ONLY the ballot in the yellow ballot envelope before sealing it.
- 4. Place the sealed yellow envelope in the return envelope along with your signed registration card. Do not include the registration card in the yellow envelope.

- **5**. Seal the return envelope, attach postage, and mail to:
  - Barton County Electric Cooperative 91 West US Highway 160 Lamar, Missouri 64759.
- 6. State statute requires that ballots must be mailed. No mail-in ballots can be accepted if they are delivered to the Cooperative in person or put in the drop box at the BCEC office.
- **7**. Mail-in ballots must be received by the close of business on Wednesday, May 3, 2017.
- **8.** Ballots cast by Business and Church organizations must be done by an officer of the organization or provide written authorization to act on its behalf.
